

excluding Delhi State Co-operative Agricultural Marketing and Supply Federation Ltd;

- (iii) One representative of weavers (Handloom) co-operative societies;
- (iv) One representative of Industrial co-operative societies (excluding HandloomCooperative Societies)

 /Leather/Labour/Transport Co-operative Societiesincluding individual members;
- (v) One representative of consumer stores/housing cooperative societies;
- (vi) One representative of other backward classes co-operativesocieties(Reserved);
- (vii) One representative of SC/ST cooperative societies (Reserved);
- (viii) One representative of women cooperative societies excluding Delhi State Women Co-operative Marketing & Service Federation Ltd (Reserved).

Note: - For the purpose of SC/ST/OBC and Women Co-operative Societies mentioned in subclause(vi), (vii) and (viii) above, the membership in such co-operative society of respective category shall be

exclusively women or person belonging to SC/ST or backward classes respectively.

(2) The election of the different categories of representatives shall be by votes of the same category of the

co-operative societies for their representatives.

The nomination of the authorized representatives of the member societies, are hereby invited, in terms of clause 3 of Schedule- II of the DCS Rules 2007. The nominations will be accompanied by resolution passed by committee of the society and the specimen signature and recent photograph of the authorized representative of the society, duly attested by the President, Secretary or Managing Director of the society. The photocopy of registration certificate of the society, proof of your society being a member of The Delhi State Cooperative Bank Ltd. and attested copies of the Audit Reports of the society for the year 2007-08 to 2022-23 will also be required to be enclosed to the nominations.

Therefore, I call upon you to hold a meeting of the Managing Committee of your society and appoint only one of your members to represent your society in the said election. Name of the authorized representative be conveyed to the undersigned, in Annexure, "A" (Part I & II). The authorization shall specifically state if the representative appointed by you is also empowered to contest the election on your behalf for Member of the Board of Directors of the Bank or if he/she is authorized to propose/ second some other member/ member society of the Bank for election.

Kindly take note of the fact that in case you fail to convey the above requisite information within the specified time, you will not be able to participate/ contest in the process of election to the Board of Directors of the Bank. Authorization letter in the enclosed form shall act as an Identity Card and your

authorized representative shall be allowed to cast vote on behalf of your society only on production of this card which must be attested by the President/ Secretary/Managing Director of your society. A passport size photo of the authorized representative should be also affixed on the authorization form duly attested by the President/Secretary /Managing Director of the Society.

In case the audit report of one or more year are not available with you, an affidavit from the President/Secretary of the society in the format attached as Annexure-1 along with certificate from the concerned auditor on his letterhead in the format attached as Annexure-2 be submitted along with the nomination form.

The nomination, in terms of this letter, should reach the undersigned on or before 5:00 p.m. on 30.04.2024 at the address given in this letter.

The list of the authorized representatives of the member societies shall be prepared and displayed in the office of the undersigned and notice boards of the Bank and will also be uploaded on the website of The Delhi State Cooperative Bank Ltd., 15 days prior to the date of inviting nomination for the elections.
